INTRODUCTION

Topic Paper 3 focuses on the extent to which character has been, and could be, identified in different areas of Suffolk and the county as a whole through local government publications.

First, we must ascertain the purpose of doing this and the relevance of character to the Suffolk Design project. A general definition of character is 'a set of qualities that make a place or thing different from other places or things'. But this begs the question as to what these qualities are and what are relevant to creating good design.

According to Understanding Place: character and context in local planning (Historic England, 2012), characterisation reveals the patterns and connections within a place, spatially and through time, for example in relation to buildings and street patterns, and the views and perceptions of people, such as their experiences and memories.

The visual and sensory experience of a place can therefore also be an important aspect of how people feel about the environment in which they live. Characterisation is also concerned with the local context and patterns of overall character rather than focusing on individual sites, buildings and their fabric.

Many would argue that character is important because it makes one place distinct from another, not necessarily better or worse but recognisably different and that this is important to create a sense of identity and belonging for a group of people.

It teases out the particular quality that places have, whether a building, village, district or county. Some of this is self-evident in that a town may have a clear medieval layout and buildings that support this character; but we should be taking the understanding of character deeper and understand more clearly all the different layers and generators of character and why places are what they are today. Character develops, emerges and continues to emerge from a melee of historical, economic, environmental, cultural and social conditions giving a distinctive feel to a place or space. It is a designer's responsibility to understand this recipe, for within this understanding lies the key for unlocking appropriate designs at every scale and informing on the nature of how a place might grow and develop character in the future. It is about not going against the grain and not fighting against prevailing

This topic paper looks at the scope of information on character available, whether this is adequate and

where the gaps area. It is to be read in conjunction with Topic Paper 1 since that references the importance that planning policies give to character. The factors contributing to character of place are wide and various. Those that have been most successfully analysed are the landscape and built form. Settlement patterns are referred to but need further characterisation covering demographics, travel patterns as well as historic, social and cultural background. This therefore makes the current characterisation in publications often quite narrow in that they tend to be too focussed on history, aesthetics and appearance and not on deeper characterisation and patterns of development and how they relate to economic and social factors. For example, there is little accessible information on land and building values or ownership patterns, travel patterns, economic catchment areas, types of investment and culture. All these have a bearing on the character of Suffolk's places and spaces today. A more comprehensive list of factors that contribute to character is contained within appendix 1.

This is not to say that these aspects are not mentioned, rather the emphasis and analysis of available data is either difficult to access or there are gaps. We suggest that the character information that developers and designers need to be aware of, and to be readily available to make informed decisions for good design, should be wider in scope at all scales, small, medium and large.

2 SOURCES FOR IDENTIFICATION OF CHARACTER

The extent to which character has been identified has focussed predominantly on local government publications from county to parish level. There are also numerous books written about Suffolk, but the purpose here is to identify what is available within local government, how well they do this and where the gaps are. All relevant publications are listed as an appendix.

County level

- Suffolk Design Guide for Residential Areas

3 EXTENT TO WHICH CHARACTER IS IDENTIFIED

At the county level, the most concise and useful description of physical character is the Suffolk Landscape Character Assessment. The Suffolk Observatory gives very useful insights into the demographic character of different areas. Both of these are extremely useful in identifying character in Suffolk at detailed levels but are limited to the particular attributes of character they cover. On the other hand, the Suffolk Design Guide and Suffolk Manual are both limited in their scope and too generic to be useful in identifying character.

At the district level, local plans, where they address character, have limited and narrow information that is not useful particularly if considering a development proposal in a specific area of that district. However local plans are still useful for understanding the overarching factors relating to character and form the basis for neighbourhood

plans. These together with Conservation Appraisals get closer to the nub of defining a specific physical character.

SUFFOLK DESIGN GUIDE FOR RESIDENTIAL AREAS

The document originally published in 1993 and revised in 2000, aims to set out the principles, or guidance, that should be adopted by all those involved in the development of housing. As the title states, the document is solely concerned with residential development and no other types of development.

The document is subdivided under a hierarchy of headings: a) Shape of Development, b) Materials & Details, c) The Individual Dwelling, each section identifying design principles and factors at different scales. Throughout the guide, principles and

guidance adopted tend to be generic and well established architectural principles that could be applicable across most areas in the UK, not just Suffolk.

The document acknowledges that Suffolk has its own character to distinguish Suffolk from the rest of England, and that this character should be recognised and considered when making design decisions, but does not go into any depth in identifying what this character is. Only as the guide becomes more focused in scale, discussing the individual dwelling and materials, does it begin to identify characteristics of Suffolk. However these are only discussed at a generic countywide level and do not differentiate the different areas of Suffolk (i.e. medieval market towns or rural coastal areas).

The document is predominantly focused on the built environment and infrastructure (in terms of highways). The document is limited and inadequate in identifying character in Suffolk.

SUFFOLK MANUAL AND OTHER GUIDANCE DOCUMENTS

The Suffolk Manual is a 'good practice guide' for works to highway, public spaces and sensitive spaces. Comprising of four separate volumes: Conservation Manual, Countryside Manual, Surface Dressing Manual, and Materials Manual, the documents are very pragmatic and focused on highways works (a significant issue at county council level).

As with the Suffolk Design Guide, the manual focuses on the principles when making design decisions (i.e. the traditional character of the area should dictate the design solution), rather than identifying characteristics of Suffolk. When character is discussed, such as the use of different types of paving and traditional railings used in Suffolk, this is very much on a generic county level and not related to specific areas of Suffolk. As with the Suffolk Design Guide, the Suffolk Manual is also very limited and inadequate in identifying character.

KEY STRATEGY DOCUMENTS

A number of key strategy and plan documents exist at county level. Examples include the Suffolk Nature Strategy, Suffolk Flood Risk Management Strategy and the Suffolk Transport Strategy among others.

The documents are focused at county level and are fairly generic in identifying character although do identify most endogenous factors (refer to appendix 1) that contribute to character but not comprehensively. Information and data relating to character is typically presented in map form supported with a written summary.

THE SUFFOLK LANDSCAPE CHARACTER ASSESSMENT (LCA)

The Suffolk Landscape Character Assessment (LCA) is an interactive webpage produced jointly by all district councils and county council. It describes the landscapes of Suffolk and in particular assesses the character and qualities of these landscapes with the aim to provide a clear indication of the issues raised by and the principals to be followed when, dealing with a particular type of development.

The assessment is very specific in terms of assessing various landscape types throughout Suffolk and focuses on endogenous factors of character such as location, topography and physical geography. However the assessment does also touch on other attributes of character such as the built environment within the landscape (settlement patterns, materials) and local land use. The assessment also makes objective observations on negative and neutral character in the various landscapes of Suffolk.

SUFFOLK OBSERVATORY

This is a website developed in partnership with the district councils and county council. It is a source of useful demographic data that provides reports and analysis on Suffolk. Data from the website is used (although not solely) to provide data for neighbourhood plans, parish plans, and village profiles. As with the Suffolk LCA, the Suffolk observatory has data across various levels from county through to parish levels. It is presumed that the Suffolk observatory is used more by local government at various levels to produce reports and documents and not so much by designers or developers. This could be due to its existence not being widely known outside local government.

In terms of identifying character the website is focused solely on demographics and does not mention any other attributes of character. However this is very helpful in giving a fuller picture, which, if integrated with other sources, could be extremely useful in describing a more rounded view of Suffolk's character.

A HISTORICAL ATLAS OF SUFFOLK

This is a publication that explores the past of Suffolk in in terms of geology, archaeology, social and economic history and the buildings of Suffolk. The aim of the guide is to collate a substantial amount of information and data previously unrelated into one place and presented in map form (of Suffolk County) with supporting text on each theme and type of data.

Although the focus is very much historical, the character of Suffolk is identified in exploration of a number of attributes including location, physical geography, land use, the built environment (important and listed buildings), infrastructure, demographics, and economics.

The document is comprehensive and useful in identifying character across Suffolk although from a historical perspective. It is also worth noting the method in which data and information is collated and presented as a map, identifying character against a geographical location. The atlas could be said to be a forerunner of the Suffolk LCA and the Suffolk Geographic Information System (GIS) although presenting very different information.

LOCAL PLANS AND POLICIES

As identified in Topic Paper I each district and Ipswich borough has a local plan, although some are in development with districts merging. The scope of the local plan is to set an overall approach to all types of development within the district or borough. Local Plans typically include a 'portrait' of the district – 'where we are now'. These are data based and mainly quantitative so difficult to assess patterns within a district and therefore difficult to relate to character.

The Local Plan for Suffolk Coastal identifies settlement patterns so giving a sense of the different character of places. It also sets out to examine "the distinctiveness of the Suffolk Coastal district." The plan looks at what the district has to offer, and what needs protecting and enhancing. It does this by examining attributes of character that are specific to that district but still at a broad level. These include location, climate (climate change and impact on flooding), topography, land use, infrastructure, demographics, economy, but not so much on the physical built environment such as, building details or materials. It is worth noting that the local plan also identifies negative or neutral issues relating to character that need addressing.

SUPPORTING PLANNING DOCUMENTS AND GUIDANCE

There is a range of Supporting Planning Documents (SPD) and Guidance produced by the various district and borough councils across Suffolk, some of which are discussed elsewhere in this Topic Paper. For example, Suffolk Coastal District Council adopts the Suffolk Design Guide as a SPD, in East Suffolk, conservation area appraisals are SPDs, and in Ipswich Borough, Urban Characterisation Studies are adopted as SPDs. The more useful SPDs and guidance for identifying character are the area specific documents such as conservation area

appraisals and urban characterisation studies (see below for more detail). Development Briefs are another SPD that identify character in specific localities. Although focused on a specific area these are similar to the local plans in that they are very much an overview and do not go into any depth. These are not as adequate as conservation area appraisals and urban characterisation studies in identifying character.

CONSERVATION AREA APPRAISALS AND MANAGEMENT PROPOSALS

There are 170 Conservation Areas in Suffolk (15 within Ipswich) of which 140 have appraisals published by district and borough councils leaving 30 without appraisals (29 of these within St Edmundsbury DC (West Suffolk)). Conservation areas under Broads National Park Authority are covered under East Suffolk DC (Waveney DC).

These documents are based on a designated conservation area and are a review of the area (in consultation with the local community). The appraisal identifies the features within the designated area that contribute and justify its conservation status, drawing up proposals for its preservation and enhancement. The intention of the documents is to provide more exacting standards for proposed development, but not to stifle development. In identifying the character of the area, the appraisals tend to focus on endogenous factors of character such as location, topography, land use and built environment (materials and details) as well as the historical background (built environment, social and economic), at a more focused and comprehensive level than the Suffolk Design Guide.

However Conservation Area appraisals typically do not identify character attributes such as climate, topography, physical geography, demographics, or economics and are generally not as comprehensive as the best neighbourhood plans.

Furthermore, some conservation area appraisals also identify and discuss negative or neutral characteristics of the area, which is useful to the designer in understanding and considering what the existing issues are in the area when making design decisions.

NEIGHBOURHOOD AND PARISH PLANS

Neighbourhood and parish plans are both community led documents that allow local communities to influence planning in the area in which they live or work. One aim of these community led plans is to identify how distinctive character and features of a place can be conserved and enhanced,

and ensure local characteristics are taken into account when decisions relating to proposed development are made.

By their nature, both documents are area specific and in terms of identifying character can range in comprehensiveness. Some parish plans only consist of demographic data, whereas others examine a much broader range of qualities attributed to identifying the character of the area.

A neighbourhood plan has more statutory weight than a parish plan and refers to the local plan and polices. The neighbourhood plan can be seen as another layer to the local plan that brings focus to identifying character in a specific area. Although a parish plan does not have a statutory status, they can be useful as a source of local information and assist in identifying areas of local distinctiveness.

There are large numbers of either neighbourhood or parish plans that now exist across Suffolk. However, as there is no legal requirement for communities to prepare these documents there are gaps. They are also not consistent in content; therefore some plans are more comprehensive and useful than others in identifying character.

NEIGHBOURHOOD PLANS

There are approximately 83 neighbourhood plans across Suffolk that are either adopted, or in progress to being adopted (East Suffolk – 32, West Suffolk – 7, Babergh and Mid-Suffolk – 44, Ipswich Borough Council – 0). The better ones are typically more useful than conservation area appraisals and urban character studies in identifying character as they identify a broader range of character attributes and examine these in-depth. Neighbourhood plans are also generally more consistent in content than parish plans. In addition to what is typically identified in a Conservation Area, there is more discussion on land use, infrastructure, demographics and economics. Attributes that are typically covered include

- situation and proximity in relation to other nearby settlements (villages and major towns),
- land use (descriptive overview with supporting data
- topography
- built environment settlement patterns, materials and details
- infrastructure road networks and communications
- demographic data based (more focused area-specific version of data used in Local Plans)
- economy descriptive overview with supporting data, types of local employment

Members of neighbourhood plan steering groups often have a reservoir of local knowledge and expertise in terms of for example local history, ecology and biodiversity, which can be harnessed.

Lawshall Neighbourhood Plan, as an example, has a supporting Character Assessment document identifying a wide range of character attributes for very specific character areas within the study area – mainly related to the built environment but does also identify other attributes such as topography and land use.

Another example of best practice, although outside of Suffolk, is Thame Neighbourhood Plan, a large market town in South Oxfordshire with a parish population of approximately 11,000. Maintaining its character as a real market town was embedded into the plan's vision statement. The plan used a detailed character assessment at the 'strategic' level to decide where new development should go and by setting out policies relating to more detailed design issues.

A number of tools and sources exist to aid in the development of neighbourhood plans including Planning Aid which provides useful templates for undertaking community-led character assessments:

PARISH PLANS

There are 60 parish plans all in Babergh and Mid-Suffolk. They vary wildly in content so difficult to say how useful they are in identifying character. At one end of the spectrum they identify character in terms of demographics based on a community questionnaire. At the other end of the spectrum they identify a wider range of character attributes including social, environmental and economic, built environment, infrastructure, demographics (using data from Suffolk Observatory). They are not as useful as neighbourhood plans for identifying character and often are more focused on a 'vision' for the parish.

URBAN CHARACTERISATION STUDIES

Produced by Ipswich Borough Council, these documents are area-based studies that identify distinctive characteristics of urban areas in Ipswich. The studies are very area-specific and cover areas

of Ipswich that are not conservation areas (which have their own appraisals – see above). The aim of these documents is not to provide prescriptive guidance but to identify the features that define the sense of a place so that these can then be reflected in the design of any proposed development.

Although the documents identify only endogenous factors of character such as location, topography, land use, built environment, infrastructure and historical background, they are comprehensive and a useful source of local information.

Documents have a section titled Character Areas that interestingly focuses on character in terms of visual appearance and aesthetics. There is a summary section at the end that focuses on the built environment (visual appearance and aesthetics) though other attributes of character (listed in appendix) are examined as part of the study. Attributes of character examined are discussed in-depth.

TOWN AND VILLAGE PROFILES (WAVENEY DC)

Village profiles mainly exist for villages and towns in what was the Waveney District, but do exist in other areas of Suffolk. Under Waveney District Council, now East Suffolk, a number of town and village profiles were produced in 2014. A village profile is a document that presents a range of statistical data for a specific town or parish. The data is based on the 2011 census and the Suffolk Observatory.

Character attributes covered are location, built environment – (types and numbers of houses), demographic and economic information but is mostly tabulated as data which includes:

- Facilities within the town/parish
- Typical home (i.e. house types, number of bedrooms, occupants)
- Age demographic
- · Gender demographic
- Number of households
- · Housing tenure
- Dependent children
- · Occupancy of bedrooms
- Working age population
- Employment
- Socio economic classification
- Education
- Health
- Transport

The document can be seen as very useful, as

statistical data for a very specific area identifying abstract qualities of character that are not apparent in the physical environment and aren't typically covered in other documents available (although some Neighbourhood and parish plans do incorporate the same data).

The document could also be useful over time with the re-publication of current revisions, giving an indication of how different types of data develop over time.

PUBLIC BODIES AND AMENITY SOCIETIES

Natural England have subdivided the country into National Character Areas (NCA), areas that are defined not by administrative boundaries but by natural attributes such as landscape, biodiversity, geodiversity and economics. There are four NCA profiles that overlap with the administrative boundary of Suffolk:

- NCA Profile: 82 Suffolk Coast and Heaths
- NCA Profile: 83 South Norfolk and High Suffolk Claylands
- NCA Profile: 85 The Brecks
- NCA Profile: 86 South Suffolk and North Essex Clayland

NCA profiles are guidance documents that can be used to inform decision making of potential development. Each profile integrates current evidence and knowledge to describe the natural and cultural features of that particular area. The profiles provide a broad analysis of various attributes of character within the study area focusing on landscape and the natural environment. Character attributes such as location, climate, topography, land use, built environment, infrastructure and economy are identified. The Suffolk LCA map references the NCA profiles as a supporting document, and both are similar in focus, however the NCA profiles provide more in-depth information.

Other public bodies and amenity societies such as Historic England and the Campaign for Rural England, have a number of publications discussing character but typically at a national level and seldom specific to Suffolk. The Suffolk Preservation Society and other amenity societies such as the Ipswich Society and Bury Society don't identify character but rather keep abreast of and provide a voice on current issues relating to the built environment and planning in Suffolk.

4 THE EXTENT TO WHICH CHARACTER COULD BE IDENTIFIED

WHAT ARE THE MISSING GAPS IN EXISTING INFORMATION TO IDENTIFY CHARACTER?

On examining the extent to which character has been identified, the focus is predominantly on physical attributes of character: the visual appearance and aesthetics of a place. It is less focussed on demographics, settlement and travel patterns, types of economy and social and cultural aspects.

The existing Suffolk Design Guide and Suffolk Manual are examples where identification of character is too generic and not in-depth, whereas at the other end of the scale neighbourhood and parish plans are more useful as they tend to identify a broader range of attributes of character at an in-depth level. However, it is in the nature of these documents they are area specific and don't examine beyond their boundaries or the areas in between. Conservation area appraisals typically do not identify character attributes such as climate, topography, physical geography, demographics, or economics.

Furthermore, neighbourhood plans and parish plans are not compulsory and therefore have limited coverage of settlements meaning designers only have the local plan and policies to refer to in these instances. These are too generic and can feel removed from the area that is being considered for development. Conservation area appraisals by their nature only exist for designated conservation areas leaving many gaps, although the Urban Character appraisals in Ipswich are a good example of an attempt to fill these gaps. Also, the content of these documents varies across the county, resulting in an inconsistency in both content and their availability.

On the other hand, tools such as the LCA and Suffolk Observatory focus on a wider range of factors effecting character and have a scope that transcends different scales of area from countywide to parish. These sources contain a wealth of specific information and in particular neighbourhood and parish plans use the demographic data from the Suffolk Observatory.

Other useful data and information that will help with characterisation, such as land and building values and economic catchment areas does already exist in the public domain and could be incorporated. These sources should be identified. Currently this information is scattered, not readily accessible and where available is not presented in a way that is practical or accessible to inform design decisions at the present.

HOW COULD A WIDER UNDERSTANDING OF CHARACTER BE IDENTIFIED?

First, the various qualities and factors that are seen to influence character, need to be identified and a process agreed to access and collect this data. Secondly geographically the coverage of individual settlements is sporadic and limited to conservation areas and neighbourhood plans. To cover Suffolk or districts as a whole would be a huge undertaking and this is where local plans and countywide guides have tried to achieve but they fail because they cannot be place specific. However, there is a level of characterisation at the county level that could show common patterns in particular settlements due to the character of their location as suggested in the Hertfordshire Guide to Growth.

HOW WOULD CHARACTER BE PRESENTED?

The question is how would this information be brought together and become easily accessible. How is this information processed to be useful for designers, developers and planners to form a sound basis for making decisions? And how is this information made available at various scales from countywide to individual villages?

The Suffolk Observatory and the Suffolk LCA have a wealth of information that allows users to identify character in Suffolk at various scales and in different ways. This information resides in a Geographic Information System (GIS), and this could be extended to encompass all information on the character of and within Suffolk highlighting different character.

The basis of GIS is the map and geographical location. As a system it is designed to capture, store, manipulate, analyse, manage and present all types of data to relate otherwise unrelated data and bringing distinct patterns and character to the fore.

As a tool it can be used in both problem solving and decision-making processes, as well as for visualization of data in a spatial environment.

Geospatial data can be analysed to determine (1) the location of features and relationships to other features, (2) where the most and/or least of some feature exists, (3) the density of features in a given space, (4) what is happening inside an area of interest (AOI), (5) what is happening nearby some feature or phenomenon, and (6) and how a specific area has changed over time (and in what way).

All relevant information and data from across the county from different levels of government and raw background data from other sources could be pulled together into the one GIS map. This means various types of information would be available in one place – a 'one stop shop' for designer's to go to. The GIS map will allow users to access and use this information specific to the areas they are developing in, but across various scales. It would not replace existing documents such as neighbourhood plans etc. but used as tool that can interpret and make accessible all this data. In turn, a countywide GIS map could be very useful in the future development of neighbourhood plans and parish plans. The map would enable communities and neighbourhood

plan groups to understand their local areas spatially especially as some groups do not have access to graphic design expertise or the capacity to produce spatial plans.

5 CONCLUSION

Suffolk's countywide Landscape Character Assessment has most successfully identified character at the county scale. On the other hand, at the local level the character of the built environment is best caught by conservation appraisals and neighbourhood plans. However the coverage of the county's character is obviously restricted to only these places and excludes much of the remaining county. Local plans try to compensate for this but the guidance and information tends to be too generic to be useful. The scope of characterisation overall is generally focussed on the physical aspects of built environment and less on the relationship between settlements and their social, cultural and economic character. There is data on this available in sources such as the Suffolk Observatory and outside the public sector that could be analysed and integrated to enhance the characterisation. This could be captured as part of an integrated information hub linked to a GIS map. It would signpost designers and developers to the most appropriate level of information in order that they may respond and imaginatively test their proposals against the prevailing character at whatever scale they are working at.

APPENDIX 1

Factors contributing to the character of places can be categorised into two groups: endogenous and exogenous. Endogenous factors are the local, internal characteristics that create a place's identity. Some examples of endogenous factors are:

• Location - Site or situation

- Climate
- Topography Height of the land, relief
- Physical geography Drainage, floodplain, soil type, geology, landform, field patterns, vegetation
- Land use Settlement patterns, industrial, commercial, agricultural, public and community, housing, minerals, water, recreational, parks and green spaces
- Built environment density, scale, grouping and orientation of buildings, roof shapes, architectural styles, local materials and detailing, form and function of streets and spaces
- Infrastructure Road and rail networks, cycle ways and footpaths, waterways, airports, energy
- Demographic Age structure, ethnicity, wealth, poverty, health, culture
- Economic Sector (primary, secondary, tertiary)

Exogenous factors are external influences on a place's identity. They are caused by a place's relationship with other places. Exogenous factors include:

- People Migrants or workers come from outside a place to live or work
- Capital Investment from a business based outside the area
- Resources Raw materials, transport infrastructure
- Ideas ideas to shape and change a place brought in by urban planners, architects, businesses and artists
